ORDER

Sub: Release of third Installment of Rs.87.50 Lakhs each to 48 RUSA beneficiary Govt. First Grade Colleges (GFGC), as Grant-in-Aid for Development of infrastructure, under Rashtriya Uchcharat Shiksha Abhiyaan (RUSA) for the year 2017-18.

In accordance with MHRD approval in the 6th Project Approval Board (PAB) meeting, a sum of Rs. 2 crore (two crores) is here by sanctioned to RUSA beneficiary 48 Govt. First Grade Colleges, for Development of infrastructure, under Rashtriya Uchcharat Shiksha Abhiyaan (RUSA) for the 12th plan period. Against sanctioned amount, approval is hereby granted to release Rs. 87.50 lakhs to each college (Rupees eighty seven lakhs fifty thousand only) as third instalment in 2017-18 (including Rs.52.50 lakhs as Centre share and Rs.35.00 lakhs as State share) in accordance with MHRD, sanction orders No.F.No.24-34/2014-U.policy (KARIGU&C2-Gen), F.No.24-34/2014-U Policy (KARIGU&C2- SC), F. No 24-34/2014-U Policy (KARIGU&C2-ST) dated 29.6.2017 and Department of Higher Education sanction order No. ED 42 EGov 2017, dated 30.10. 2017.

1. The sanctioned amount of Rs. 87.50 lakhsto each college will be debited to the following plan budget heads as per breakup given below:
 - a. 2202-03-103-1-03-059
 - b. 2202-03-103-1-03-422
 - c. 2202-03-103-1-03-423
 - d. 4202-01-203-1-11-059
2. After deducting 1% (42 Lakhs for Maintenance and monitoring as per RUSA guidelines), balance amount of Rs. 4158 Lakhs is transferred from KSHEC RUSA account (A/C No. 0788101062648) to Power plus Account bearing number 0788132000003 maintained at Canara Bank, Madhavanagar Branch, Bangalore. From this account the Principals of beneficiary collegesare authorized to withdraw the fund as and when the amount is to be given to the vendor, with the approval of CCE. This amount has been transferred to power plus account on21.02.2018.

The sanction is subject to implementation of the scheme as per RUSA guidelines issued by Govt. of India, Karnataka State Higher Education Council (KSHEC) and the following terms and conditions:

- i. **The Institutions shall take approval from Commissioner, Collegiate Education, Bangalore, before taking up any new construction and payment shall be made with the prior approval from Commissioner, Collegiate Education, Bangalore, for the total allocated fund.**
- ii. The institutions shall carry out the project strictly in accordance with the financial and physical norms as approved by the National Mission Directorate RUSA, MHRD, Government of India, Department of Higher Education, Govt. of Karnataka and follow the guidelines issued by the Executive Council, KSHEC from time to time.
- iii. All the prevailing State Govt. Financial Rules, KTPP rules and Norms are to be followed strictly
- iv. The institutions shall maintain proper accounts of the expenditure incurred out of the grants and shall ensure utilization of funds only under approved heads.
- v. The Utilization Certificate for the installment received shall be furnished to the State Project Directorate, RUSA, within stipulated time. Non submission of Utilization Certificate on time shall debar institutions from release of next installment.
- vi. While submitting the proposals for release of further Grants under the scheme, the institutes shall submit the certified copy of Utilization Certificate of the previous Grant

received along with the statement of expenditure showing clearly the actual expenditure incurred and the unspent balance available.

- vii. The Utilization Certificate supported by audited statement of expenditure to the effect that the grant has been utilized for the purpose for which it has been sanctioned shall be furnished to the SPD as early as possible after the closure of the financial year.
- viii. The Institution shall maintain an audited record of assets acquired wholly or substantially out of the grant and a register of assets shall be maintained by the institutes.
- ix. The beneficiary institutions shall map RUSA account details on PFMS portal to facilitate online fund transfer and monitoring. All payments to the vendor should be through PFMS only.
- x. The KSHEC or its nominee shall have the right to check/verify the accounts to satisfy that the funds have been utilized for the purpose for which they were sanctioned.
- xi. The institutions shall furnish photographs of construction carried out under the project at periodic intervals to depict three phases , i.e
 - a. Before commencement
 - b. The intermediate stages and
 - c. After the completion of the project
- xii. The institutions will have the Governing Bodies and Monitoring bodies in the form of Board of Governors (BOG)/ Syndicate/ Executive Council and Project Monitoring Unit (PMU) which will monitor the progress of Project on a regular basis and shall provide guidance for improving the performance of the institutions in project implementation.
- xiii. All New constructions, Renovations and Equipments created/acquired under the grant should display the RUSA logo for which this grant is being used.
- xiv. Quarterly progress report shall be submitted to the KSHEC Technical Support Group (TSG), RUSA, for monitoring.
- xv. Monitoring will be based on action plans prepared by each project institution and achievements made with respect to a set of norms, which are defined in the institutional development plan.
- xvi. As per the Guide lines of RUSA, Institution has to give their commitment to make
 1. Institutional governance reforms
 2. Academic and examination reforms
 3. Accreditation Commitments
 4. Project Management Teams
 5. Equity Commitments
 6. Commitments on research and innovation efforts
 7. Faculty recruitment and improvement
 8. Establishment of MIS
 9. Regulatory compliance.
